Student Enrollment Agreement

By signing this agreement, I acknowledge that I have read, understand, and agree to abide by the policies and expectations of Pulse Dance Collective.

Please initial each statement.

_____ 1. Tuition & Fees

I understand that all tuition, registration fees, costume deposits, competition fees, and other studio fees are non-refundable and non-transferable.

_____ 2. Enrollment Commitment

I understand that enrollment at Pulse Dance Collective is for the entire dance season (August–June). Withdrawal does not release me from financial obligations already incurred.

_____ 3. Tuition Payments

Tuition is due on the **1st of each month** and becomes late after the **5th**. A **\$15 late fee** will be added beginning on the **6th** of the month. Accounts with outstanding balances may result in suspension from classes, rehearsals, performances, competitions, and other studio activities until the account is current.



4. Missed Classes

No refunds or tuition credits will be issued for missed classes. Makeup classes may be offered at the discretion of the Studio Director.

5. Withdrawal Policy

Written notice of withdrawal must be submitted **30 days prior** to the intended withdrawal date. Tuition already billed or owed remains the responsibility of the family.

6. Registration Fee

The annual registration fee is **non-refundable** and must be paid before enrollment is complete.

7. Class Enrollment

Pulse Dance Collective reserves the right to cancel, combine, or reschedule classes due to insufficient enrollment or other unforeseen circumstances.

8. Studio Policies

Students and parents agree to follow all policies outlined in the Pulse Dance Collective Parent & Student Handbook. Failure to comply may result in probation, suspension, or dismissal from the studio.

9. Class Placement

Class placements are determined solely by the Artistic Director and faculty. Students may not enroll in classes above their assigned level without approval.



_____ 10. Media Release

I grant Pulse Dance Collective permission to photograph, video record, and use my dancer's image, likeness, or performance for promotional, educational, advertising, website, and social media purposes without compensation.

_____ 11. Liability Waiver

I understand that dance is a physical activity involving inherent risks. I voluntarily assume these risks and release Pulse Dance Collective, its owners, faculty, staff, and affiliates from liability for injuries or damages that may occur while participating in studio activities.

_____ 12. Attendance & Punctuality

Students are expected to arrive on time and attend classes regularly. Excessive absences or repeated tardiness may affect class placement, performance opportunities, and company membership.

_____ 13. Dress Code

Students must wear the required dress code for each class. Instructors reserve the right to have students observe rather than participate if they are not properly dressed or prepared.

_____ 14. Studio Conduct

Students are expected to demonstrate respect, kindness, discipline, and professionalism toward instructors, staff, fellow dancers, parents, and studio property at all times.

_____ 15. Cell Phones & Electronics

Cell phones, smart watches, and other electronic devices must be silenced and put away during class unless authorized by the instructor.



_____ 16. Food & Drinks

Only water is permitted inside dance studios. Food, gum, and other beverages must remain in designated areas.

_____ 17. Parent Communication

Parents are responsible for reviewing studio emails, newsletters, and the Parent & Student Handbook to stay informed of studio policies, schedules, and important announcements.

_____ 18. Respectful Behavior

Pulse Dance Collective maintains a positive and respectful environment. Disrespectful behavior, bullying, harassment, inappropriate language, or misconduct by students or parents may result in disciplinary action, including dismissal from the studio.

_____ 19. Fundraising (Dance Company Only)

All Pulse Dance Collective Dance Company members are required to participate in studio fundraising efforts throughout the season. Fundraising helps offset the costs of competitions, costumes, travel, guest choreographers, and company events. Families choosing not to participate may be responsible for paying the fundraising equivalent determined by the studio.

_____ 20. Parent Observation

Parents and guests may observe classes only during designated observation weeks or with prior approval from the Studio Director. This policy helps maintain a focused learning environment for all dancers.



_____ 21. Dance Company Commitment (Company Members Only)

Dance Company membership is a season-long commitment. If a dancer withdraws from the company after accepting their placement, the family remains responsible for any outstanding tuition, costumes, choreography, competition, or travel expenses that have already been incurred on the dancer's behalf.

_____ 22. Acknowledgement

I acknowledge that I have read this Enrollment Agreement and the Pulse Dance Collective Parent & Student Handbook. I understand that this agreement is binding for the current dance season and agree to follow all studio policies.

I/We acknowledge that we have read and understand the policies, procedures, and expectations outlined in the **Pulse Dance Collective Student & Parent Handbook**.

I/We agree to abide by all studio policies while enrolled at Pulse Dance Collective. I/We understand that these policies are in place to provide a safe, respectful, and positive learning environment for all dancers and families. Failure to comply with the policies and expectations outlined in the handbook may result in disciplinary action, including suspension or dismissal from Pulse Dance Collective at the discretion of the Studio Director.

I/We understand that dancers are not permitted to participate in classes, rehearsals, performances, or company activities until all required enrollment documents have been completed and submitted. This includes the completed Registration Form, Handbook Agreement, Tuition Agreement (if applicable), and any additional required studio forms.
